I am writing to notify the Board of Education of the City School District of Albany of my interest in filling the Board vacancy created by my recent resignation.

In May, I believed that the board's procedure to reach a determination for my removal would not be fair and rather than submit to this unbalanced legal process in the middle of a superintendent search, I did what I believed would be best for all and chose to resign. At this point, though, the board's accusation, that private conversations between me and Dr. Kimberly Wilkins, interim superintendent and an ex-officio member of the Board of Education, violated board confidentiality which might impact the superintendent search, is now irrelevant.

I would like to return to serving the people of Albany as a member of the school board. I am Albany's duly elected representative for this position. Further I proudly represent several underrepresented demographics and given my recent tenure on the board, I am the most qualified candidate for this appointment.

Historically education provides opportunity, hope and salvation for poor students and their families. It is imperative that this school district figure out a way to educate all of Albany's children. Currently Albany is a tale of two cities — one where education and opportunity thrives and another where the lack of a basic education limits potential and career prospects and maintains a sense of hopelessness.
